The board accepted the resignation of Don Marlow and Gary Larson agreed to be put on the ballot as the 6th candidate to fill Don Marlow's 1 year commitment to the board.

The minutes of the November meeting were approved unanimously by the board.

Officers Reports

President's Report

President's report was read by Cathy Eccleston (see attached, filed as given). He informed the membership that the Freemans have agreed to put motion lights and fans in both the Cantina and Siesta outside sitting area. They have agreed to install cameras in both the front and rear gates.

We have changed the date of January 2020 Board of Directors meeting from January 7, 2020 to January 14, 2020 because we will have a guest speaker form the FMO, John Sacvucci, Director at Lodge. Treasurer's Report

Audit Committee reported on the yearly audit. Sharon stated that the audit was acceptable, books are in order.

New Business:

Sharon Lindsey address the membership. She stated that the Bylaw's that are now being used are not valid. She explained that no bylaws can be changed at a Board of Directors meeting. This must occur at a membership meeting. All changes that occurred in April, 2018 were invalid. The changes that occurred in December at the Annual meeting were not valid because there was not 30 days from the November meeting to the Annual Meeting, because the November 2018 meeting was changed to a week later because of first Tuesday in November was voting day. Our bylaws state "Such motion or resolution shall be posted in the clubhouses at least (30) days prior to the date of meeting at which said motion or resolution shall be place on the agenda for consideration." There were only 28 days from the Board of Directors meeting to the annual membership meeting.

It was determined that at this time, the Bylaws from 2016 are the valid ones and should be used/passed out to the membership. She also stated that in the New Year there would be a Bylaws committee set up to address any changes in 723 and brought before the membership.

This means that the changes to yearly dues are not valid, all money paid above the \$5.00 dues will be moved to cover part of 2020 dues. Sharon also raised that the HOA should not be holding committee money in the HOA account. This is a tax violation. We claim it on our taxes, but it is not our money. Because the April Bylaw changes are not valid, we are returning all committee money back to the committees, these funds will be disbursed at the Annual meeting.
